Dunkin Donuts - Please note that it is permissible to purchase products at kosher approved Dunkin Donuts in Baltimore on *Motzai Pesach* - April 30, 2016 only after 9:50 p.m. Only the Dunkin Donuts located at 1508 Reisterstown Road (at Old Court Road) and 7000 Reisterstown Road (near Fallstaff Road) are under the certification of Rabbi Sholom Salfer. Please carefully read the in-store sign to confirm which products contain *cholov stam* powdered and liquid milk, as well as *cholov Yisroel* and *pareve* products.

THE DUNKIN DONUTS LOCATED NEAR THE PIKESVILLE LIBRARY HAS NO HECHSHER, SERVES TREIF MEAT PRODUCTS, AND IS NOT KOSHER APPROVED.

The following oat matzos can be used on Pesach (in addition to those listed in the Pesach Guide): Kestenbaum Machine Oat Shmura Matzos - Only when bearing the following: "*Chug Chasam Sofer Bnei Brak- Kosher For Pesach.*" **Kestenbaum Hand Oat Matzos** - Only when bearing Manchester Badatz-Harav Westheim. **Pupa Tzeilim Hand Oat Matzos** - Kosher for *Pesach*. To order, contact Mrs. K. Beleck at 410-358-9580.

All brands of baby carrots bearing an OU symbol are KFP without a "P" designation. **Sunmaid Raisins and Sunsweet Prunes and Prune Juice** are KFP when "P" appears next to the kosher symbol on the label. **Dole and Fresh Express salads** are KFP when bearing a STAR-K P near the date code.

Baltimore Chometz Burning - Friday, April 22, 2016 between 6:30 and 11:30 a.m. at Pimlico Race Course, Clubhouse Parking Lot. ENTRANCE FROM HAYWARD AVENUE, 3 blocks east of Park Heights Avenue. After *chometz* is burned, *Kol Chamira* is recited. In Baltimore, one may eat *chometz* up until 10:16 a.m., and burn *chometz* no later than 11:33 a.m. Candlelighting is 7:33 p.m.

Last *shatnez* hours before *Pesach* - Thursday, April 21, 2016 from 2:30 p.m. to 3:30 p.m. at the STAR-K office.

An *eruv tavshilin* is required on the last day of *chol hamoed*, Thursday, April 28, 2016.
