

2020 PASSOVER PRODUCTS THAT DO NOT REQUIRE ADDITIONAL PASSOVER CERTIFICATION

with the conditions noted under each category

- **Alcohol** - Following alcohols are not chometz
 - Isopropyl alcohol
 - Benzyl alcohol
 - Methyl alcohol (methanol)
 - Stearyl alcohol
- **Aluminum Foil Products**
- **Baby Food**
 - Gerber (when bearing OU)- Carrots, Squash - acceptable for Passover *l'chatchila* (even for adults).
 - Gerber (when bearing OU)- Green Beans, Peas - *kitniyos*
- **Baking Soda**
- **Blush/Rouge, powdered** - All
- **Candles** - (paraffin) does not need a hechsher
- **Charcoal Briquettes** Unflavored
- **Cocoa**- Any domestically produced 100% pure cocoa, with no additives, may be used. However, if label states that it is processed in a plant that processes kitniyos or chometz, then it requires a reliable KFP certification.
- **Coconut Secret (STAR-K)**- Coconut Aminos, Coconut Crystals, Coconut Flour, Coconut Nectar, Coconut Vinegar
- **Coffee** (with year round certification)
 - Folgers- Regular & Decaf- Unflavored Instant
 - Nescafe Tasters Choice- Regular Unflavored Instant including House Blend & French Roast
 - Trader Joe's- Regular Unflavored Ground
 - Coffee Beans - unflavored may be roasted on the same machinery as decaf and need a Pesach hechsher.
- **Dishwashing Soap** (with year round certification)
 - Ajax
 - Cascade
 - Dawn
 - Joy
 - Palmolive (Regular, Ultra)
- Seventh Generation
- Trader Joe's
- Up & Up

- **Eggs** - Should be purchased before Passover. Since chicken feed may contain *chometz*, it is customary not to eat eggs that were laid on Passover.
- **Fish** - All frozen raw fish products should have reliable certifying agency Passover approval. If Passover-approved frozen fish is not available, or the frozen fish was already purchased without Passover approval, then it should be washed, ideally before Pesach. This should not be done over a Pesach sink. Fresh KOSHER fish with skin may be bought anywhere and rinsed.
- **Floor Cleaner**
- **Frozen Fruit**- unsweetened additive-free, without syrup, citric acid, ascorbic acid, Vitamin C, and that do not have an issue with insect infestation (e.g. Frozen Peaches & Frozen Melon)
- **Frozen Juices**-100% pure white grapefruit or orange frozen juices without sweeteners, additives, preservatives or enrichments (e.g. calcium) added
- **Furniture Polish**
- **Garlic** - peeled, Spice World brand with a Star-K is fine for Pesach if product of USA
- **Grains** -The following grains (whole grains only) may be used on Passover. Purchase from manufacturers that do not process *chometz* grains. Consumers are required to carefully check grains BEFORE *PESACH* for extraneous matter:
 - Flax
 - Hemp

- **Hand Sanitizer** - Due to coronavirus concerns, this year any may be used. Should be purchased before Pesach.
- **Ice** – All plain-water bagged ice may be used.
- **Lemon Juice** (with year round certification)
 - ReaLemon Brand Lemon Juice (Reconstituted)
 - ReaLime Juice
- **Milk** - In areas where Kosher for Passover milk is not available, milk should be purchased BEFORE Passover.
- **Nuts** Raw, whether they are Slivered, Whole or Chopped Nuts (e.g., almonds, pine nuts, walnuts, etc.) without preservatives or other additives, such as BHT or BHA in corn oil, are approved for Passover. If label states that it is processed in a plant that processes kitniyos or chometz, then it requires a reliable KFP certification. The following processed nuts require KFP certification: Dry roasted, toasted, blanched, and ground. Whole and half pecans are similar to any raw nuts mentioned above; however, pecan pieces and midget pecans must bear a KFP symbol. Many consider peanuts as *kitniyos*, which are not permissible on *Pesach*.

 - Sunrise Olive Ranch - Extra Virgin Oil*
 - Terra Delyssa - Extra Virgin Oil*
 - Viola - Organic Virgin Coconut Oil*

- **Salt**- Non-Iodized, that does not contain Dextrose or Polysorbates (sodium silicate is not a problem)
- **Scouring Pads/Sponges**- without soap
- **Seltzer**- Any unflavored seltzer that does not list any citrates as an ingredient may be used.
- **Silver Polish**
 - Goddard's
 - Hagerty
 - Weiman
 - Wrights
- **Sugar, Granulated**- All pure cane or beet sugar with no dextrose added. (excluding confectioner's and brown sugar which need KFP)
- **Tea** (with year round certification)
 - Lipton Tea Bags- Reg Unflav, Decaf Unflav
 - Nestea- Reg Unflav Instant Powder (not Decaf)
 - Tetley Tea Bags- Reg Unflav
- **Vegetables, Fresh Peeled** (with year round certification)
 - Lancaster Foods - Carrots, Acorn Squash, Butternut Squash, Eggplant, Potatoes, Yams, Yellow Squash, Zucchini
 - Healthier Way - Butternut Squash, Sweet Potato
 - Little Salad Bar - Peeled Garlic
 - Nature's Promise - Organic Butternut Squash, Organic Squash Medley
 - West Creek - Bulk Garlic, Whole, Fresh Chopped Garlic, Peeled Garlic
- **Vegetables, Frozen** (with year round certification)
 - Healthier Way - Frozen Beet Veggie Noodles,
 - Frozen Butternut Squash Veggie Noodles,
 - Frozen Carrot Veggie Noodles, Frozen Sweet Potato Veggie Noodles, Frozen Zucchini Veggie Noodles
 - Wegmans - Frozen Butternut Squash Noodles, Frozen Sweet Potato Noodles, Frozen Zucchini Noodles
- **Wax Paper**
 - Reynolds Cut-Rite
- **Water** Any bottled filtered, spring or distilled water does not require certification, even if it includes fluoride or minerals.

Exceptions: The following waters require KFP certification: Flavored, Containing citrate or zinc lactate, 5 gallon containers (since they are reused)
